- *Non-refundable*

## **OBLIGATIONS**

- *Financial*
  - Stay Motivated, DBA is a **non-refundable** 12 month program. Member (you) are responsible for full payment of the program.
- *Cost*
  - **Annually** \$499 with a \$100 signing bonus totaling \$399
  - **Monthly** \$39.99 dues and \$129.00 non-refundable, one-time, monthly payment set-up fee due at time of joining program.
- *Automatic Monthly Deductions*

  - Member’s (you) banking account or debit card will be automatically deducted starting from join to date until 11 months after; payments will automatically terminate.
- *Mentoring Sessions*

Sessions are conducted on a weekly basis at 30 minute intervals.

  - Member (you) are responsible for setting up coaching weekly sessions as well as initiating mentoring call with mentor. If weekly coaching call are missed there will be no retroactive payments from program cost for missing sessions in the 12 month commitment.

- Session Deactivation
  - Member (you) can deactivate account for 3 months in the 12-month commitment of program at this time payments are put on hold as well as the program mentoring sessions.

- Monthly Subscribers
